YOU ACKNOWLEDGE AND AGREE THAT, BY INSTALLING THE SOFTWARE, YOU ARE INDICATING THAT YOU HAVE READ, UNDERSTAND AND AGREE TO BE BOUND BY THESE TERMS. IF YOU DO NOT AGREE TO THESE TERMS, THEN DO NOT INSTALL OR USE THE SOFTWARE. If you accept or agree to these Terms on behalf of, or in your capacity as an employee, agent, or representative of a company or other legal entity, you represent and warrant that you have the authority to bind the company or other legal entity to these Terms and, in such event references to "you" will refer and apply to that company or other legal entity.

The Software is provided by TechSmith Corporation (referred to herein as "TechSmith" or "we" or "us"), a Michigan corporation whose principal business address is 14 Crescent Road, East Lansing, MI 48823 U.S.A.

#### 1. License Grant

Subject to your compliance with these Terms, TechSmith grants to you a limited, non-exclusive, non-transferable, license to install and use the Software solely for your business or personal purposes. These Terms governs your use of the Software.

#### 2. Trademarks

All trade names, trademarks, service marks, logos and other brand features (collectively, "Marks") used in or with this Software which identify TechSmith products and services or a third party's products and services are proprietary Marks of TechSmith and/or the relevant third parties. Except as expressly stated herein, nothing in this Software shall be deemed to confer on any person any license or right on the part of TechSmith or any third party with respect to any such Marks.

### 3. Intellectual Property Rights

Unless otherwise stated herein, TechSmith is and shall remain the owner or licensor, as applicable, of all intellectual property rights, including, but not limited to, copyright, patent, and database rights in the Software and all TechSmith created and owned content and materials used by TechSmith in connection with providing the Software. You may not publish, distribute, extract, re-utilize, or reproduce any component part or portion of the Software or TechSmith created and owned content or materials in any material form (including photocopying or



storing it in any medium by electronic means) other than in accordance with the limited use license set forth herein.

## 4. Applicable Law and Jurisdiction

These Terms shall be governed by the laws of the State of Michigan, U.S.A. to the extent U.S. federal laws are not applicable, without regard to their conflicts of law principles. The application of the United Nations Convention on Contracts for International Sale of Goods is expressly excluded. You agree to the exclusive jurisdiction of the Courts of the State of Michigan, U.S.A. and the United States federal district court located in Ingham County, Michigan, U.S.A. This Agreement has been prepared in the English language and such version shall be controlling in all respects and any non-English version of this Agreement is solely for accommodation purposes. The parties to these Terms waive personal service of any and all process upon them and consent that all such service of process be made by registered mail and shall be deemed to be completed 5 business days after the same shall have been deposited in the United States mail, postage prepaid. You waive any objection based on forum non conveniens and any objection to venue of any action instituted under these Terms by TechSmith in any jurisdiction. If you are a federal, state, or local government entity in the United States using the Software in your official capacity and legally unable to accept the controlling law, jurisdiction or venue clauses above, then those clauses do not apply to you. For such entities, these Terms and any action related thereto will be governed by the laws of the state of your residence.

### 5. General

These Terms constitute the entire agreement between TechSmith and you with respect to your installation and use of the Software. TechSmith's failure to enforce any right or provision in these Terms shall not constitute a waiver of such right or provision. If a court should find that one or more rights or provisions contained in these Terms is invalid, you agree that the remainder of the Terms shall be enforceable.

### 6. Registration and Password

To obtain a license for the Software you must be 16 years or over. We reserve the right to refuse service to anyone for any reason at any time. You agree that the information that you provide to us in any registration for the Software and at all other times will be true, accurate, current and complete. You also agree that you will ensure that this information is kept accurate and up to date at all times.

When you create an account, you will be asked to provide a password. You are responsible for all activities that occur under your password, and you should keep your password confidential. You must notify TechSmith immediately of any

unauthorized use of your password or if you believe that your password is no longer confidential. We reserve the right to require you to change your password if we believe that your password is no longer secure.

TechSmith collects anonymized information for fraud and piracy prevention including the number of downloads or installations of the Software through a "call-home" system which may be sent to a TechSmith or a third party cloud server for storage or further processing by TechSmith or its vendors that provide license compliance services. Such information may include the IP address and computer and session ID.

#### 7. License Grant in Your Content

TechSmith does not claim ownership rights in the material you upload to the Software (your "Content"). For the sole purpose of enabling us to fulfil any instruction or orders from you with respect to your Content (the "Purpose"), you grant to TechSmith a non-exclusive, royalty-free license to use, copy, distribute, and display your Content solely as necessary for the Purpose.
